### C.E.O. Report

Ms. Anderson-Wise presented a staffing update. She shared that staffing is very stable, one staff member is scheduled to retire at the end of the summer.

Ms. Anderson-Wise shared an update to the Org-Redesign process. She stated that this alignment of staff will best serve the organization. The next steps will be to create and update job descriptions and conduct a full salary analysis and prepare a new salary schedule for review and approval by the full board over the summer.

Ms. Anderson-Wise shared that the status of the current work location plan. We are still following government recommendations and guidelines. Over the summer the future workplace plan will be revised and define the work plan.

## Financial Reports for the Period July 1, 2020 Through May 31, 2021

Mr. Michael Blote reviewed the comparative statement of financial position as of May 31, 2021, and May 31, 2020. Total liabilities and net assets were \$9,039,990 for the current year as compared to \$9,291,583 the prior year.

Mr. Blote reviewed the summary statement of activities for the period July 1, 2020, through May 31, 2021. He also reviewed individually the statement of expenses for Program Services, Research and Industry Relations, Administration and Overhead.

Total revenues through May 31, 2021, were \$5,913,492 and total expenses were \$5,655,578 for a increase of \$257,914 in net assets.

Mr. Blote also shared the Cash and Investments for months ending May 31, 2021 and May 31, 2020.

### Out-of-State Sales as of May 31, 2021 and May 31, 2020

Mr. Blote reviewed the primary clients and total out-of-state sales for May 31, 2021 and May 31, 2020. Total sales were \$5,038 for the current year as compared to \$24,363 for the prior year.

## Program Services Year-End Report

Ms. Shannan Young, Program Director, Food System + Access shared the progress and successes representing the organization's collective efforts from February 1, 2021 – May 15, 2021.

She shared the 2020-2021 Organizational Priority Outcomes highlighting some of the internal and external priorities that staff has worked on throughout the year. Ms. Young shared the updated dashboard, showing the result of the educational engagements with 3.8 million students, adults and parents educated as of May 15, 2021.

Ms. Young shared additional opportunities that staff has leveraged throughout the year that directly impact children and that have provided multiple education platforms and increased occasions to reinforce healthy eating messages.

Ms. Young shared the many ways Dairy Council of CA staff have demonstrated leading the cause to elevate the health of children and families through their unique expertise, partnerships and collaboration with various stakeholders throughout the state during the past year.

#### Virtual Poster Sessions

Ms. Tracy Mendez, Program Director, Nutrition Education introduced the Let's Eat Healthy Activation progress to date. She stated that when the brand was created the goal was to expand Dairy Council of CA's impact, by inspiring others around our vision and values andto elevate the work of others who are aligned to our vision and values. Ms. Mendez introduced Ms. Renee Farias, Community Nutrition Adviser from the Central Valley.

Ms. Farias shared about an educator in her region who is a champion for nutrition education. Mr. Scott Brown, a PE teacher at Gaston Middle school in Fresno has utilized Dairy Council of CA's curriculum in his middle school for many years. Mr. Brown was able to transfer the curriculum to a digital platform during remote learning classes with his students to increase engagement. Mr. Brown created a best practice to screen students for food insecurity through the nutrition lessons and connected them and their families to healthy food access.

Ms. Phoebe Petersen, Community Nutrition Adviser, Supervisor presented an example of the Let's Eat Healthy Movement work that is also focused on food

access in the school environment, and is a great example of how Let's Eat Healthy is being championed through strategic partnerships. In partnering with California Milk Advisory Board to support school nutrition, together we piloted a Milk Cooler Bag Support project to keep milk cold during curbside meal pick-ups. There were 4,900 bags created and distributed to 55 school districts throughout the state, supporting school meal programs and elevating access to cold milk across the state as demonstrated through the pre and post-surveys.

Ms. Ashley Rosales, Program Director, Nutrition Science introduced Ms. Kristal Shelden, Project Manager II and Ms. Megan Holdaway, Project Manager who shared the outcomes of the Well-Nourished, Brighter Futures initiative and stakeholder convening. The Well Nourished Brighter Futures initiative serves as the foundation for the Let's Eat Healthy movement in bringing together leaders with shared values and goals to help all children thrive.

Ms. Shelden shared that a small group of core organizations came together to collaborate in developing the stakeholder convening and initiative launch. A convening report was developed as a result of the convening. The report captures participant's input during the convening and is intended for use by the meeting participants and others to help inspire action within our respective areas of work to improve nutrition education, facilitate and provide access to nutritious foods, and advocate for every child's nutritional needs.

Ms. Megan Holdaway shared some additional details of the initiative including the circulation of a to all the stakeholders who participated. The purpose of this survey was to not only gauge the success of the convening but also to solicit feedback on how to best continue collaborating and further the Well-Nourished, Brighter Futures Initiative. The results found that overall, strong evidence that good nutrition starts in the first 1,000 days of life and helps lay the foundation for a child's future health well into adulthood.

Ms. Maureen Bligh, Program Director, Marketing + Communications introduced Ms. Rachel Bonachea, Communications Manager and Mr. Alex Vigil, Program Manager, Marketing. Ms. Bonachea shared the communications dashboard.

Ms. Bonachea identified three key areas of influence—Advocacy, Social Media and Owned Channels—and provided year-over-year increases and noteworthy highlights, including 170% increase in subscribers on YouTube year-over-year due to strong video content.

Mr. Alex Vigil, Program Manager, Marketing provided an update to the new Let's Eat Healthy website. Mr. Vigil shared the guiding principles to measure the effectiveness of the new website. He shared the analytics of the traffic, traction and transactions relating to the website. He shared information on the pilot social media influencer program, which is educators who are also social media influencers to help increase the awareness of our nutrition education resources but also create user-generated content for credibility.

## 2021-2022 Proposed Budgets

Mr. Blote reviewed the proposed 2021-2022 budget with total proposed revenues of \$6,498,500 and total expenses of \$7,259,166 for a total decrease in reserves of \$760,666.

The proposed 2021-2022 budget for Program Services is \$6,150,814 (85% of proposed expenses), Research and Industry Relations is \$59,000 (2%), and Administration is \$1,049,352 (13%). The overhead expenses incorporated into the total expenditures are \$895,935.

### 2021-2022 Proposed Capital Expenditures

Ms. Anderson-Wise presented the proposed 2021-2022 budget for property and equipment. The total proposed budget is \$89,500.

## Thursday, September 9, 2021

#### Call to order

Chairman Dolan called the meeting to order at 1:33 p.m. He welcomed everyone to the special 2021 Dairy Council of CA Board of Directors meeting. He welcomed new board member Dennis Roberts, CEO Crystal Creamery to the board. He recognized Ms. Arlene VanderEyk for her dairy being one of the winners of the 2021 Innovation Center Sustainability Award.

#### C.E.O. Report

Ms. Anderson-Wise provided a brief update on the progress of the organization. She mentioned that the 2020-2021 Annual Report is being prepared and will be sent out in October. She stated that the 2020-2021 Annual Financial and CDFA Audit will begin on September 13, 2021. The Sacramento office remains open and staff can work in the office as needed. For the Mobile Dairy Classroom instructors and Community Nutrition Advisers who work in the field, including in schools and communities, we are monitoring this carefully. With input from the California Department of Food and Agriculture, Dairy

Council of CA is recommending adopting the California State COVID-19 Verification and Testing Requirements. Those guidelines highly encourage all employees to get vaccinated. For those who choose to not be vaccinated, guidelines are currently being developed. These guidelines would require weekly COVID testing and should be published and enacted by the end of September.

After dialogue, a motion was made to table this discussion until more information becomes available from the state and we have clear protocols to move forward.
